Philosophical Discourse "body" as an inherent part of the "human" lasts forever and has many interpretations, written in the socio-cultural context. Many explications "flesh" forms in the modern field of philosophical research a variety of approaches, paradigms and perspectives. In scientific research are theoretical generalization and new solution to the problem of human physicality, as the phenomenon of physical culture.

1. An important methodological principle research value of human physicality and physical training is the use of multidimensional approach:a) physicality - a substrate of human activity, which is a multidimensional entity that exists in three dimensions: biological (natural) body, physicality internal, external physicality and constructed at their intersection;b) physicality, in our opinion is a set of information, energy, system-structural and functional properties that include every single human biological systems;c) a person in its main essential characteristics -body-social education. 2.
